**AIREDALE TERRIER CLUB OF METROPOLITAN NEW YORK**  
**CODE OF ETHICS**

1. Each member will abide by the rules and regulations of The American Kennel Club and The Airedale Terrier Club of Metropolitan New York, and will do all in his/her power to protect and advance the interests of the Airedale Terrier.
  2. Each member will maintain complete, accurate and up-to-date records of breedings, pedigrees, sales and transfers in order to preclude any possibility of error in identification of any individual dog, or doubts as to parentage of any particular dog or litter, and preserve these records for at least five (5) years. Whenever applicable, a written contract form will be used to specify all understandings with other parties.
  3. Each member will adhere to the following principles regarding selling, advertising and breeding:
    - (a) will not sell at wholesale or consign to retail outlets such as pet shops, mail order businesses, or similar commercial enterprises, and will not donate or sell a dog to any business or organization to be offered as a prize in a raffle, lottery or drawing of any kind;
    - (b) will avoid advertising which tends to commercialize or cheapen the Airedale Terrier such as trade-ins, clearance sales, bargains or offering animals with extreme faults as rare, unusual or desirable specimens;
    - (c) will not advertise, represent, or sell a dog as show quality if at the time of sale that dog had disqualifying faults under AKC rules or the Breed Standard;
    - (d) will not intentionally produce cross-bred dogs;
    - (e) will endeavor to breed out any serious deviations from the Breed Standard and will breed only to improve the quality of the resulting puppies;
    - (f) will carefully consider the far-reaching benefits of spaying or neutering pet quality stock;
    - (g) will remember that he/she is dealing with living creatures, not inanimate objects.
  4. Each member will constantly seek to increase his/her knowledge as a breeder and to use that knowledge to improve the Airedale Terrier. As an exhibitor in approved forms of competition, he/she will endeavor to present to the public the best possible image of the Airedale Terrier, the dog fancy and good sportsmanship.
